## Responsible for the treatment

## How can we obtain your data?

The data that we have about you may be collected or have been collected previously through various means of data collection (online or printed forms, online or printed questionnaires, telephone calls). This data collection is part of the different actions, campaigns and initiatives carried out by the OCEAN US Foundation in relation to its partners, donors, interested parties, beneficiaries, collaborators and suppliers. In these actions, express consent will have had to be given by accepting this privacy policy, whether the data has been obtained directly by the OCEAN US Foundation or by a third party on behalf of the OCEAN US Foundation. In all cases, the data that is processed, the reason and why will be reported.

## If you are a private person

### What data do we process?

1. Data necessary to maintain the relationship and communications with you, which may be:

- Name
- Surnames
- Age
- Sex
- Preferred language
- Email
- Telephone
- Mailing Address
- Economic contribution

2. Other data in loyalty actions and other relationships such as:

- Familiar surroundings
- Interests
- Other additional data that you voluntarily provide us in future relationships and interactions with OCEAN US.

3. Additional data provided through your social networks and other applications:

We will also process any additional data that you voluntarily provide us through a social network or other application during future relationships and interactions that you maintain with the OCEAN US Foundation. This data is available depending on your own privacy settings, your use of the social network or application, as well as the privacy policies of each social network or application. We recommend that you read them carefully before providing us with data through said social networks or applications.

#### **Why do we treat your data?**

1. Manage your registration as a member, partner, donor or collaborator of the OCEAN US Foundation, as well as keep you informed through various communication channels on issues related to our activity.

2. Manage the consents for the various communications to interested parties, users, partners, collaborators, volunteers, in the OCEAN US Foundation, and from all possible online and offline channels.

3. Manage possible queries, complaints, incidents and claims made by the user. For this, the OCEAN US Foundation will carry out those data treatments necessary to attend to the request required by the user. In this regard, data such as your name, surnames, e-mail, telephone, province, postal code, as well as information regarding whether the user has any type of relationship as a donor with the Fundación OCEAN US foundation.

4. Send information about the OCEAN US Foundation, its activities and actions by telephone, postal mail, SMS, email or instant messaging.

5. Invite to acts and events organized by the OCEAN US Foundation.

6. Request donations, registration as a regular donor, donation increases, sale of solidarity products or other types of participation.

7. Collection management of donations, regular donations and charity purchases.

8. Sending the donation certificate.

9. Profiling activities based on information voluntarily provided by you.

### **For what reasons can we process your personal data?**

This treatment is legitimized as it is necessary to comply with the contractual obligations derived from said relationship or to respond to the request.

The processing of your personal data to send information about activities, campaigns or initiatives of the OCEAN US Foundation similar to those in which you have participated, responds to a legitimate interest of our entity and is authorized by current regulations.

### **If you act on behalf of a company**

#### **What data do we process?**

The processing of your data is limited to those contact details relating to the company, entity or organization for which you work or collaborate.

#### **What is the purpose why we treat your data?**

1. Maintain commercial, contractual or collaborative relationships between the OCEAN US Foundation and the entity for which you work or collaborate.

2. Manage communications by digital and postal means about the activities, campaigns, actions and initiatives about which you have requested information or sent some type of request, and for which you have given us the consent to contact you.

### **Transfer of data to third parties**

Your data may be provided to third parties in the following cases:

1. In the event that public administrations so request, in compliance with the legal obligations to which the OCEAN US Foundation is subject.
2. Assignments to service providers who need to access this data on behalf of the OCEAN US Foundation. These providers will have signed in their contracts specific annexes of confidentiality and treatment of data required by current legislation.
3. Transfers to third parties necessary to comply with the obligations related to the actions and campaigns in which you have voluntarily participated and provided your data, such as banking entities or payment gateways.
